Management Discussion of Fund Performance

June 4, 2024

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the ETF's performance and outlook in the year ended March 31, 2024 (the "period"). If the ETF was established during the period, "period" represents the period since inception.

In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the ETF. In addition, net asset value ("NAV") refers to the value of the ETF as calculated for subscription and redemption purposes, on which the discussion of ETF performance is based.

Investment Objective and Strategies

The ETF seeks to replicate, to the extent reasonably possible and before fees and expenses, the performance of the Solactive Green Bond USD CAD DM CAD Hedged Index, or any successor thereto. It invests primarily in investment grade green, social and sustainable bonds. Foreign currency exposure is hedged back to the Canadian dollar.

Risk

The risks of the ETF remain as discussed in the ETF's Prospectus.

The ETF is suitable for short- to medium-term investors looking for a North American fixed income fund with exposure to green, social and sustainable bonds to hold as part of their portfolio, who can handle the volatility of bond markets and who have a low tolerance for risk.

Results of Operations

Investment Performance

During the period, the ETF returned 2.3% (after deducting fees and expenses). This compares with the Solactive Green Bond USD CAD DM CAD Hedged Index return of 2.8%. All index returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

The U.S. Federal Reserve and the Bank of Canada paused interest rate increases in the period after two 25-basis-point rises. Treasury yields fell from peak levels. Inflation decreased significantly, and wage growth moderated but remained around 5%. The Federal Reserve remained focused on its 2% inflation target, signalling that it could lower interest rates in 2024 despite robust economic indicators and persistently high inflation. The Bank of Canada continued to express concerns about inflation but also signalled the possibility of a policy rate cut later in 2024, backed by weaker economic data.

Through the period, the ETF used a sampling methodology to invest in broadly diversified securities that collectively approximate the full index in terms of key characteristics. Alternatively, the ETF may invest its assets directly in the bonds that make up the index, holding each bond in approximately the same proportion as its weighting in the index. The ETF uses derivative instruments to hedge its foreign currency exposure back to the Canadian dollar.

The difference in performance between the ETF and the index resulted primarily from management fees and other operating expenses, and from the sampling methodology of the ETF.

Over the period, changes were made to the ETF's holdings to reflect changes in the composition of the index.

Environmental. Social and Governance ("ESG") Impact

Green, social and sustainable bonds included in the index must satisfy a set of guidelines from the International Capital Market Association and are verified by the Climate Bond Initiative. The issuer must clearly indicate the intended use of the bond's proceeds. Green bonds finance projects or activities that promote climate or other environmental sustainability purposes ("Green Projects"), such as renewable energy, pollution prevention and control, and climate change adaption. Social bonds finance projects that address a social issue ("Social Projects"), often aimed at target populations such as those living below the poverty line and marginalized communities. Examples include food security and sustainable food systems, socioeconomic advancement and affordable housing. Sustainable bonds are issues whose proceeds are used to finance or refinance a combination of Green Projects and Social Projects. All designated eligible Green Projects and Social Projects should provide clear benefits, which will be assessed by the index provider and, where feasible, quantified by the issuer.

The index is rebalanced annually based on these guidelines. Over the period, 18 securities were added to the ETF and 49 were eliminated, for a total of 171 at period-end. Green bonds increased to 92% of the ETF's fixed income investments from 89%, social bonds decreased to 0% from 1% and sustainable bonds decreased to 5% from 7%. The ETF's investment strategy is to invest primarily in such bonds, thereby directly funding green, social and sustainable projects.

Net Assets

The ETF's net assets increased by 14.5% during the period to \$229.0 million. This change was composed primarily of \$5.0 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$24.0 million due to net unitholder activity (including sales, redemptions and cash distributions).

Recent Developments

Because the ETF is an index fund, neither market expectations nor recent developments affect the composition of the portfolio.

Related Party Transactions

Management Fees

The management expense ratio ("MER") for the ETF during the year ended March 31, 2024, was similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in the ETF. The MERs are presented in the *Financial Highlights* section of this report. The ETF paid management fees to the Manager at the annual rate of 0.25%.

The management fee for the ETF is calculated and accrued daily as a percentage of its NAV. The ETF's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the ETF, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, providing other services and licensing the index, and to pay for all costs and expenses (other than certain specified fund costs as more fully described in the Prospectus) required to operate the ETF.

Other Related Party Transactions

The ETF did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions in the period.


Past Performance

The ETF's performance information assumes all distributions made by the ETF in the periods presented are reinvested in additional units of the ETF.
